One of the primary goals of the MASA Foundation is to promote leadership development among Minnesota's school leaders. In support of that objective, the MASA Foundation is announcing an exciting new direction.

The Foundation Board has created a permanent endowment for the purpose of promoting the professional development of school leaders. The fund currently has an endowment of \$70,000, and its earnings will be invested in developing opportunities for MASA members to further their education in educational administration. Earnings will also be used to provide outstanding programs in professional development to new members and mid-career members.

The Foundation will work with each MASA component group to identify activities to fund that will be the most meaningful and helpful to their members. These might include activities for aspiring administrators, orientation for leaders in new positions, or

training for seasoned administrators. Examples that the Board has discussed might include:

- Week-long comprehensive academies for superintendents, special education administrators, or other administrators, somewhat like a mini Bush experience.
- Support for administrators to attend national seminars, workshops, or conventions, or perhaps even an international experience.

The Foundation is able to move in this direction because, thanks to the vision and hard work of a several of our colleagues, it has spent a number of years raising the principal to begin the endowment. Funding activities have included personal gift campaigns, the Fall Foundation Golf Tournament, and the Spring Silent Auction.

Our History

The MASA Board and Executive Director Norm Maguire started the MASA Foundation in 1985 specifically to raise funds to remodel and furnish the then new MASA building. The campaign was very successful and when the remodeling campaign was completed in 1986, the Foundation became dormant.

In 1995, MASA retired members Dale Birkeland and Don Bungum approached MASA with the suggestion that the Foundation could become an important funding vehicle to support initiatives that the regular MASA budget could not sustain. Their presentation to the MASA Board was met with enthusiasm and the Foundation was re-established.

Since 1995, the Foundation has worked to raise funds for a number of endeavors, including: scholarships for high school students opting for careers in education; funding the publication of the white paper, "The Status of the Superintendency;" grants for a number of aspiring educators to attend workshops on how to become a superintendent; and providing travel grants for a number of administrators studying the Singapore education system.

A quote that I heard many years ago, when I was involved in strategic planning for our school district, has had a strong impact on how I view our work

for the future. MASA members have met and welcomed Commissioner Yecke, Governor Pawlenty, members of the governor's staff, and legislative leaders. We have shared our vision for education in Minnesota and sought new paths of input and cooperation. We are still on that journey and the paths may shift quickly, but many Future ...

It's a Myth! K-12 Education is Not Doing "Okay" Financially in this Legislative Session

Educators seem to be constantly in the

position of saying "thank you" for K-12 education not being cut in funding this year. Yet when we look at the print out of the funding districts will see for next year, the list looks pretty bleak. FY 04 is slim. And FY 05 is slimmer!

If your inflationary costs were held to only 2%, you would need about \$100 per pupil unit to just break even. Most districts either see small decreases or increases. A

few have really big losses. The only districts that will see substantially more money next year are those that happened to pass an operating referendum last fall.

Yes we can be glad we aren't Cities, Human Services or Counties. But don't let anyone fool you to think that education is getting off 'scott free'. It is important that parents and citizens in your communities know the facts.

Adolescent Obesity - A Growing Health Concern

No one can say that the American teenager is underfed! In the last two decades there has been a startling increase in obesity among our adult population and our children. As a result, medical professionals see large increases in type 2 diabetes in children as well as many related illnesses relating to overweight. This is a significant health issue.

There are some in Minnesota that feel that the Minnesota Legislature should pass laws governing how schools function in regard to the nutrition and activity levels of our children. It is MASA's position that the passage of statutes in this regard is unwarranted and unnecessary. MASA feels school leaders, as they become educated on this issue, will help to make changes in school operations that appropriately address the issues of nutrition and exercise.

One initiative that school leaders can take now is to consider calling **Notebook ...**Continued Page 6

Parent Notification Service Helps Distrist Comply with NCLB

We are aware of the daunting task districts will face to comply with all aspects of the No Child Left Behind Legislation and we believe we have good news for you regarding one part of that task – your responsibility to provide certain notifications to parents as required by the Act. Most school districts across the country are in the process of developing these notifications without much assistance.

TransACT, the company that developed EduPortal® and the TransACT® Translation Library has developed an online NCLB Parent Notification Service that contains over 30 NCLB parent notifications that are ready to use now. This Service will be updated regularly to reflect new federal NCLB regulations. The service also includes an "Accountability and Compliance" section of reference guides and summaries for administrators to assist them with requirements related to timelines, accountability and other management responsibilities.

The NCLB Parent Notification Service is delivered via a password-protected Internet site and covers many of the immediate needs school districts have as end-of-school deadlines approach under NCLB. for a 'request for proposals' relating to products and conditions governing vending machines in their schools. A model RFP, developed by the CFL nutrition section, is posted on the MASA website. This RFP helps a school district to create a healthy mix of vending products for children to purchase.

Another issue has to do with the health content of foods served in the food service programs in our schools. In order to become cost effective, school lunch programs are forced to provide more and more ala Carte foods. In doing so, attention must be made to providing foods that are healthy. We need to move away from fast service foods that are high in fat content wherever possible. It will be a challenge to balance good nutrition with foods that are attractive to students accustomed to a fast food diet.

It is essential that school leaders come to understand these nutrition issues and begin the process of education and change on their own so statutes and laws are not necessary within this arena. Labor Relationships - A Big Legislative Policy Issue

The Public Employees Labor Relationship Act (PELRA) was passed about thirty years ago and has been amended a couple of times since. Each of the amendments were appended to strengthen the hand of labor in negotiations. Now, in 2003, there is talk at the legislature of shifting the relationship back in the other direction.


Nearly everyone is respectful of the right of government employees to negotiate for salary and working conditions. Possible changes in PELRA would not take away this right, but rather would alter the conditions under which negotiations take place. MASA, along with MSBA and several other associations, is asking the legislature to consider a change in the end game of negotiations. These changes will make the process less contentious and allow

school districts and other units of government to settle contracts within their means.

A part of the change is a call for binding, last offer arbitration at the point of impasse and prior to a strike being considered. The arbitrator would take in to account the financial condition of the school district in making an award. A school board would have the right to reject the arbitrator's award, but then the employee bargaining group would have the right to strike.

This change will be subject to extensive debate and some amendments as it wends it's way through the House of Representatives and the Senate committee processes. Expect Governor Pawlenty to be supportive of changes in the PELRA bargaining law.

members have helped us influence our future.

Secondly, the Board recognized that we needed more of our MASA members to help us create this positive future. Members from all over the state have answered this challenge and volunteered to assist in our efforts. Many of you have been directly involved in meetings with legislators, state officials, business partners, higher education personnel, and many other contacts. You have served on state education committees, MASA committees and subcommittees. and have spoken and written eloquently all over this state about the issues that impact students and districts in your communities and this state. An MASA committee has reviewed and created a new governance structure to make new paths that respond to diverse urban, rural, large cities in greater Minnesota, and suburban needs. We are welcoming both ethnic and

gender diversity in our leadership structure and activities and are working to ensure that all members have a voice in creating our future. The Board unanimously approved the new governance structure, and we are hopeful that the membership supports it, also.

Third, the Board views that it is imperative that we as an organization promote and encourage individuals to aspire to district-level positions. The health of our educational system in Minnesota demands talented and committed leaders. This task is a large challenge over which we don't have complete control, but we do have influence on how young staff members view our roles and us. Each day MASA members are encouraging young educators to seek leadership opportunities and providing them with assistance in that journey. We are promoting the important role that we all play in serving the

needs of students. Positive images and messages about our leadership roles continue to come forward from our members. We have sought to not be the whiners and complainers but rather the architects of education, so that other educators will want to join our ranks. MASA has created professional development activities to assist new administrators, helped with technology through the Gates grant, and is the process of developing a program that will assist certified staff in Minnesota to seek administrative certification and positions in Minnesota. We must have the will to get people involved in leadership roles and create programs that will help them succeed.

MASA has been busy this year creating a positive future for our students and our state. The journey has many new paths and large obstacles, and we are not home yet. Please continue with us as we wrap up a difficult and challenging legislative session and seek to create new paths for educational success. Our journey will change our destination and us! •

Commissioner Yecke Brings Focus to the Department of Education

Ten years ago Commissioner Yecke was a concerned parent in a Minnesota school district. With her husband's military transfer to Virginia she became engaged in the political process in that state and became the Deputy Secretary and then the Secretary of Education for the Commonwealth of Virginia. She then went to work for the Federal government working in the U.S. Department of Education and was given an assignment to the White House advising the White House staff on education issues and on the administration of the Freedom Corps.

Governor Pawlenty announced the appointment of Dr. Yecchy as

Commissioner of the Minnesota Department of Children, Families and Learning in mid-January. She began work in early February and will have her hands full as she tackles issues of department morale, the Profiles of Learning, and education funding. She has expressed an interest in connecting with school district leaders

MASA has established a working relationship with the Commissioner. MASA will advise the Commissioners and the department as they move forward in tackling a number of important educational policy issues. There will be differences of opinion between school leaders and Department of Education officials. However, with a positive relationship, we have a far better chance of working together to create policies that will best serve

the children within the public schools of Minnesota.


MASA Forms Federal Advocacy Group



The Jobsite's applicant site streamlines the hiring process for both school districts and applicants. Applicants for licensed positions complete an online screening form that member districts can use to electronically screen applicants according to their own criteria.

Applicants may post their credentials (transcripts, license, letters of recommendation, etc.) to the site.

For most school districts, the annual subscription cost is less than the cost of advertising just one position in the newspaper.

And the jobsite postings and applications are available 24 hours a day, 365 days a year. Rates are determined according to district size.






